The meeting was called to order at 9:30 am. Following the welcome and introductions the committee reviewed the Equity Committee Authority and Responsibility along with a synopsis of the committee recommendations from past years.

### **EQUITY COMMITTEE AUTHORITY AND RESPONSIBILITY**

The Equity Committee, as with any other MHSAA Standing Committee, has the duty and responsibility to discuss matters of specific interest relating to equity opportunities for women and minority men and women and to then make recommendations of action to the Representative Council that involves all levels and positions within the governance of the MHSAA.

Goals are to include, but are not limited to:

1. Gather statewide data to define equity problems, direct actions and to monitor progress.
2. Promote through motivation, support and training competent coaches, officials, athletic directors, and governing board members regardless of race, ethnicity, or sex.
3. Sensitize and encourage organizations and employers to affirmatively seek women and minorities for athletic leadership training, placement, and promotion.
4. Promote the benefits of athletics and athletic leadership to students, educators, parents, and community.
5. Improve communication between the school districts, the Michigan High School Athletic Association, governing boards, professional associations, and higher education regarding the need for balanced staffing of athletic programs.

### **SPORT OFFICIALS**

Assistant Director Mark Uyl provided the committee with information relating to officials registration, new tournament procedures and current requirements for criminal history background checks.

Nearly 13,000 officials registered for 2009-10 school year. All registered officials have gone through at least one background check. There is an approximate 2 ½ year period before a new background check is made.

Collaborative efforts with MSU Womens Basketball and Reaching Higher are providing additional avenues for officials training for the newly registered and to the 2-5 year experienced official.

  - a) The committee discussed the issues of reducing season maximum contest. While these conversations will continue in other forums, the committee was concerned that fewer contests in school sports will drive students to outside organizations.

These unsporting acts/lack of civility is displayed not only in our scholastic games, but are a real source of concern in the various means of social media. ## **SPORT CUTS AND SCHOOL BUDGETS**

The committee was asked if any member experienced or have evidence that girls sports or sport levels were being cut to assist in balancing schools budgets, while boys sports or sport levels are not cut. On this specific question, no committee member had experience or evidence to support girls sports or sport levels are being cut while boys sports or sport levels are not.

Committee members do have concerns that student interest in sport participation is getting lower, that even when a sport or sport level is offered, low participation/interest becomes the driving force to eliminate the sport or sport level. The committee noted that this was not a single gender issue, but affects both genders.
