

**2008 MHSAA Individual Wrestling Finals
 March 6-8 • The Palace of Auburn Hills
 Advance Reserved Seat Ticket Information & Order Form**

1. **All-Tournament Tickets:** Spectators, coaches and officials may purchase tickets that will admit the bearer to all five sessions of the MHSAA Individual Wrestling Finals to be conducted at The Palace of Auburn Hills, March 6-8, 2008. The All-Tournament ticket will allow the bearer to enjoy the same lower bowl reserved armchair seat throughout the three-day tournament.
2. **Advance Ticket Purchase:** All-Tournament Reserved tickets for all five sessions are \$40 a set and may be ordered from Jan. 2, 2008, through Jan. 31, 2008, **exclusively through The Palace of Auburn Hills Box Office.** Orders may not bear a post mark earlier than Jan. 2, 2008 nor later than Jan. 31, 2008. Advance orders which do not adhere to these requirements will be returned to the sender. **Priority for seating location is given to qualifying wrestlers, then to advance sale purchases. No exchanges or refunds will be allowed. Parking is included in the ticket price.**
3. **Payment & Processing:** A check or money order made payable to The Palace of Auburn Hills or a valid credit card number must accompany all Advance ticket orders. A \$5.00 Palace Box Office service charge will be assessed to all orders. All orders will be processed in the order in which they are received. The Palace Box Office will provide the best available tickets in the division requested. **No exchanges or refunds will be allowed.**
4. **Maximum Orders:** There is no limit to the number of tickets an individual may order. If a group of individuals wishes to purchase tickets together, their orders should be submitted in one envelope. A \$5.00 service charge will be assessed to **each** order placed.
5. **Qualifiers:** Final qualifying wrestlers may purchase up to four All-Tournament reserved tickets after the Regional Tournament, using the special order form which will be distributed at the Regional awards presentation. **Priority for seating location is given to qualifying wrestlers, then to advance sale purchases. No exchanges or refunds will be allowed.**
6. **Public Sale:** Tickets will be available exclusively through The Palace of Auburn Hills Box Office (248.377.0100) beginning Feb. 11, 2008. All-Tournament reserved tickets only will be available for \$45 each, plus any applicable service charges.
7. **Single-Session Tickets:** Sales begin on March 4, 2008, exclusively through The Palace of Auburn Hills Box Office at a cost of \$10 for reserved seats (if available), and \$9 for general admission.
8. **The Palace of Auburn Hills Seating:** Seating has been designated by division in order that seating will be directly in view of one division of wrestling; however, spectators will be able to view all four divisions from their seats. Spectators should request tickets by division, which will result in being seated with a full view of the mats for that division of competition. For Divisions 3 and 4, tickets will be on the side of the arena opposite the mat placement, resulting in an unobstructed view of those mats. **Priority for seating location is given to qualifying wrestlers, then to advance sale purchases. No exchanges or refunds will be allowed.**
9. **Group Sales:** Upper level general admission group seating is available for all sessions for youth wrestling clubs, church groups, charitable organizations and others. A minimum purchase of 10 tickets per session is required. Contact The Palace of Auburn Hills Box Office or visit the MHSAA website for more information after January 15, 2008.
