Ticket Prices

Semifinals: \$10 per Division (2 games in each Semifinal session)
All-Finals: \$20* (4 Saturday Finals - 2 Sessions)
All Tournament: \$60* (8 Semifinals - 4 Sessions / 4 Finals - 2 Sessions)

School Ticket Allotments

- High schools classified with the Michigan High School Athletic Association for the 2018-19 school year may purchase **\$20 All-Finals tickets** in advance, according to the following maximum allotments:
Division 1 schools **maximum of 16** reserved seat tickets per session
Division 2 schools **maximum of 16** reserved seat tickets per session
Division 3 schools **maximum of 12** reserved seat tickets per session
Division 4 schools **maximum of 12** reserved seat tickets per session
Junior High schools **maximum of 2** reserved seat tickets per session
NOTE: Junior High/Middle School orders must be submitted on a second form
- Member schools may request **\$60 All-Tournament tickets** that will allow for the same reserved armchair seat for all Semifinals and Finals based on the above maximums.
- School requests and remittances are to be forwarded to the Michigan High School Athletic Association, Inc., 1661 Ramblewood Drive, East Lansing 48823, in order to be received **NOT LATER THAN MONDAY, Feb. 11, 2019**. School ticket requests received after Feb. 11, 2019 will not be accepted. Those orders received late in the period ending Feb. 11 may be returned if the available supply of tickets has been exhausted.
- Full remittance (check or money order made payable to the Michigan High School Athletic Association, Inc.) must accompany all school reserved seat ticket requests. All school requests must be signed by the superintendent of schools or the high school principal. Reserved seat tickets WILL NOT be returnable after purchase.**
