**MHSS/CA PROPOSALS**

1. Increase the number of venues used for the MHSAA Final Ski Tournament and modify the rotation.

- 8D. Administration – add "ski or hill qualified" to the following:  
Each qualifying team to the MHSAA Final must provide two workers "ski or hill qualified"...

### DISCUSSION – NO ACTION TAKEN

Allow two sanction dates for MACC races in conjunction with CUSSA sanctioned races.

Permit an individual skier who qualifies in one discipline at the MHSAA Regional to ski in both disciplines at the MHSAA Final.

Award team trophies for the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place teams at the Regional and the Final tournaments (currently 1<sup>st</sup> and 2<sup>nd</sup> only).

Require host management at the MHSAA Final Tournament to use individual qualifiers in only one discipline to be forerunners in the other discipline.

### NEW BUSINESS

The MHSAA Regional may be held any day, Monday through Friday, the week of Feb.13-17, 2012. In addition, if there is inclement weather, the host manager in conjunction with the site management and the MHSAA may move the original date of the event.

### RECOMMENDATION TO THE REPRESENTATIVE COUNCIL

1. Request the MHSAA Regional Ski Tournament be held any day, Monday through Friday, the week of Feb. 13-17, 2012. In addition, if there is inclement weather, the host manager in conjunction with the site management and the MHSAA may move the original date of the event .(10-0)
