Executive Committee Authority and Responsibility – The Executive Committee reviewed its authority under Article VII of the MHSAA Constitution and specifically its responsibility to consider each application for waiver of an eligibility requirement on its individual merits, determining if the regulation serves the purpose for which it was intended in each case or if the regulation works an undue hardship on any student who is the subject of a request for waiver. (These underlying criteria may not be restated for every subject of these minutes.)

The MHSAA is a private, nonprofit corporation, made up of voluntary membership; it is neither a state agency nor a court of law, and is not bound by any particular legal standard of review or burden of proof when applying its Regulations or while administering an internal appeal. The *MHSAA Handbook* may identify which party bears the burden of proof, depending on the particular situation or if a particular Regulation is at issue. The MHSAA staff, its Executive Committee, or its Representative Council, where appropriate, shall determine whether the circumstances in each situation, as presented to the MHSAA, warrant application or waiver of a particular Regulation or Interpretation. To make that determination, the MHSAA considers what a reasonable person given the same information would decide.

The Executive Committee was reminded that it was the responsibility of each member school involved to provide sufficient information about the specific request for the Executive Committee to reach a decision without further investigation. If information is incomplete, contradictory or otherwise unclear or has been received too late to be studied completely, the Executive Committee may deny the request for waiver or delay action. Such requests may be resubmitted to the Executive Committee with additional information at a subsequent meeting or appealed to the full Representative Council.

It is possible that some of the information presented as facts to the Executive Committee by school personnel and others may be inaccurate. However, to avoid constant repetition in this report of phrases such as “it was alleged” or “it was reported,” no attempt was made in the introduction of each waiver request to distinguish between truth, allegation, hearsay, opinion, summary or conclusion. If any information provided to the Executive Committee is inaccurate, any decision of the Executive Committee to grant waiver of a regulation shall be vacated.

The Executive Committee is not authorized to approve waiver based on alleged or actual differences between schools based on “environment,” demographics, curriculum or extracurricular offerings. A determination of undue hardship is a matter addressed to the discretion of the Executive Committee within the educational philosophy and secondary role of voluntary extracurricular competitive athletics in the academic environment. The Executive Committee will avoid making exceptions that would create precedent that effectively changes a rule without Representative Council action or local board of education adoption, which would exceed Executive Committee authority. The agreement the MHSAA has with member schools obligates the MHSAA to not change rules during the school year.

Students for whom waiver of a particular regulation is approved must be eligible in all other respects under all sections and interpretations of the regulations prior to their participation.

Adoption of these regulations, as well as policies, procedures and schedules of MHSAA tournaments, is a choice schools make locally when they consider their option of MHSAA membership. Consistent with rulings of the Attorney General and Michigan Supreme Court, schools are not bound by the decisions of the Executive Committee, but the association may limit participation in the postseason tournaments it sponsors to those schools which choose to apply rules and penalties as promulgated by the MHSAA and adopted by each member school's board of education. The MHSAA exercises no independent authority over schools or students.

Byron Center-Zion Christian High School (Regulation I, Section 1[D]) – The Executive Committee approved a request to waive Regulation I, Section 1 (D) to allow the use of 8th-grade student-athletes in their athletic programs. Zion Christian High School has 100 students in grades 9-12 for the 2023-24 school year. The request came to the Executive Committee with numbers, cause, and rationale about the positive impact of using 8th graders at Zion Christian HS. The request was to allow the use of 8th graders in all sports so that Zion Christian HS can field JV teams by using 8th-grade students.

Harbor Springs-Harbor Light Christian High School (Regulation I, Section 1[D]) – The Executive Committee approved a request to waive Regulation I, Section 1 (D), to allow the use of 7th-grade student-athletes in their girls basketball program to have a JV team. Harbor Light Christian School has 61 students in grades 9-12 for the 2023-24 school year. The request came to the Executive Committee with causes and rationale about the positive impact of using 7th graders at Harbor Light Christian HS in girls basketball starting in the Winter of 2023.

Hillman High School (Regulation I, Section 1[D]) – The Executive Committee approved a request to waive Regulation I, Section 1 (D) to allow the use of 8th-grade student-athletes in their athletic programs. Hillman High School has 123 students in grades 9-12 for the 2023-24 school year. The request came to the Executive Committee with specific numbers, cause, and rationale about the positive impact of using 8th graders at Hillman HS in their athletic programs.

Rock-Mid Peninsula High School (Regulation I, Section 1[D]) – The Executive Committee approved a request to waive Regulation I, Section 1 (D), to allow the use of 7th-grade student-athletes in their athletic programs. Mid-Peninsula High School has 56 students in grades 9-12 for the 2023-24 school year. The request came to the Executive Committee with causes and rationale about the positive impact of using 7th graders at Mid-Peninsula HS in boys and girls basketball starting in the Winter of 2023.

Ann Arbor-Father Gabriel Richard and Ann Arbor Christian High Schools (Regulation I, Section 1[E]) – The Executive Committee approved a cooperative program between these schools in boys soccer (JV and varsity) and football (JV and varsity). Ann Arbor Christian's membership was approved on September 6, 2023. The combined enrollment of 496 students will place the team in Division 3 for boys soccer and Division 5 for football. Support from the Catholic High School League was submitted.

Custer-Mason County Eastern and Manistee Catholic Central High Schools (Regulation I, Section 1[E]) – The Executive Committee approved a cooperative program in boys and girls track & field (varsity only) between these schools. The combined enrollment of 146 students will place the team in Division 4, removing one team from the division. Mason County Eastern will be the primary school. Support from the West Michigan D League was submitted.

Lake Leelanau-St Mary and Leland High Schools (Regulation I, Section 1[E]) – The Executive Committee approved a cooperative program in baseball (varsity only) between these schools. The combined enrollment of 202 students will place the team in Division 4. St Mary will be the primary school. Support from potential opponents was submitted.

Onkama and Manistee Catholic Central High Schools (Regulation I, Section 1[E]) – The Executive Committee approved a cooperative program in softball (varsity only) between these schools. The combined enrollment of 138 students will place the team in Division 4, removing one team from the division. Onkama will be the primary school. Support from the West Michigan D League was submitted.

Three Oaks-River Valley and New Buffalo High Schools (Regulation I, Section 1[E]) – The Executive Committee approved a cooperative program in softball (JV and varsity) between these schools. The combined enrollment of 333 students will place the team in Division 3, removing two teams from Division 4. River Valley will be the primary school. Support from potential opponents was submitted.

Fowlerville and Pinckney High Schools (Regulation I, Section 1[F-1]) – The Executive Committee approved a cooperative program in gymnastics (JV and varsity) between these schools. The combined enrollment of 1,534 students will keep one team in Division 1. Support from the Capital Area Activities Conference was submitted.

Holt and Mason High Schools (Regulation I, Section 1[F-1]) – The Executive Committee approved a cooperative program in boys lacrosse (varsity only) between these schools. The combined enrollment of 2,452 students will place the team in Division 1, removing one team from Division 2. Holt will be the primary school. Support from the Capital Area Activities Conference was submitted.

Okemos and Davison High Schools (Regulation I, Section 1[F-1]) – The Executive Committee approved a cooperative program in boys skiing (varsity only) between these schools. The combined enrollment of 3,215 students will keep the team in Division 1. Support from the Mt Brighton High School Skiing Association was submitted.

Troy-Athens and Berkley High Schools (Regulation I, Section 1[F-1]) – The Executive Committee approved a cooperative program in gymnastics (varsity only) between these schools. The combined enrollment of 3,258 students will place the team in Division 1, removing one team from the division. Troy-Athens will be the primary school. Support from the Oakland Activities Association was submitted.

Adrian, Blissfield, Adrian-Lenawee Christian, Adrian-Madison, Clinton, Onsted and Tecumseh High Schools (Regulation I, Section 1[F-2]) – The Executive Committee approved the addition of Blissfield to a cooperative program in ice hockey (varsity only) that existed between the other schools. Blissfield replaces Addison, who was recently removed. The combined enrollment of 3,254 students will keep the team in Division 2. Adrian will continue as the primary school. Previous support from Southeast Conference is on file.

Chelsea High School (Regulation I, Section 4) – A request to waive the maximum enrollment and maximum competition rules of the eligibility regulation was made on behalf of a 12th-grade student enrolled in his 9th semester of high school this fall. The student participated in bowling and track & field at Chelsea High School and has been enrolled at Chelsea since his 7th-grade year in 2017-18. The student was born with spina bifida, and attends the program for independent living skills through the Chelsea Public Schools. His disability has delayed his high school education. The school requests athletic eligibility during the student's fifth year of high school and athletics in 2023-24. The student's athletic participation was detailed along with medical confirmation of his disability.

The Executive Committee approved the request for waiver.

Lake Orion High School (Regulation I, Section 7) – A request to waive the previous academic credit record regulation was made for an 11th-grade student who attended Lake Orion High School during their 9th and 10th-grade years and played JV football. After moving back in with his mother, the student transferred to Lake Orion HS Virtual Academy, yet struggled academically. The move to the virtual academy came with a loss of education services, leading to a dramatic drop in academics, which led to the student passing only four of nine classes. The student is not eligible based upon this fact and summer school and credit recovery was not an option for the student. The student is now back to living in a more stable home environment with his grandmother and is thriving academically. The school requested immediate eligibility in football for the rest of the 2023 season at Lake Orion HS given the student's unique experience and the fact that he will have sat out six games this fall season.

The Executive Committee did not approve the request for waiver.

Brooklyn-Columbia Central High School (Regulation I, Section 9) – A request to waive the transfer regulation, specifically Interpretation 62 (public school of residence), was made on behalf of a 9th-grade student who recently moved between parents to live with his mother. The student attended Jackson HS at the start of the 2022-23 school year as a 9th grader, where he lived with his father and competed in soccer in 5 games. The student had attended Columbia Central Schools since 5th grade and the new change to a bigger district and with his father did not work for the student and the student moved back to live with his mother on September 18, 2023 and attend Columbia Central HS. The student has not played in the seven soccer games since reenrolling at Columbia Central. The new residence with his mother is in the Hanover-Horton Public School District. The new school requested immediate eligibility in soccer at Columbia Central HS pending an otherwise completed and approved Educational Transfer Form.

The Executive Committee approved the request for waiver with an otherwise completed and approved Educational Transfer Form.

Caledonia High School (Regulation I, Section 9) – A request to waive the transfer regulation was made for an incoming 10th-grade student who attended East Kentwood High School for his 9th-grade year and the start of his 10th-grade year before transferring to Caledonia HS. The student and family desired a new school environment for school safety and for the student. The student competed in boys basketball at East Kentwood HS. The school asked for eligibility in subvarsity boys basketball at Caledonia HS.

The Executive Committee did not approve the request for waiver.

Canton-Salem High School (Regulation I, Section 9) – A request to waive the transfer regulation was made on behalf of an 11th-grade student who transferred from Plymouth Christian High School for the start of the 2023-24 school year. The student transferred to Salem HS, the public school closest to his residence, after attending Plymouth Christian Academy since the start of his high school career. The family could not afford tuition anymore at Plymouth Christian and transferred schools. The student participated in football, basketball, and baseball at PCA. The new school asked for immediate eligibility based on the circumstances. Documentation from the former school was also included.

The Executive Committee did not approve the request for waiver.

Detroit-Cass Technical High School (Regulation I, Section 9) – A request to waive the transfer regulation was made for a student initially enrolled at Detroit-Communication & Media Arts High School as a 9th-grade student and competed in JV volleyball and varsity softball. The student applied for admission at Cass Tech High School before her 9th-grade year but was not initially granted admission. In August of 2022, she was granted admission but her mother was sick with COVID-19 and the family missed the acceptance window for Cass Tech HS, so the student started and finished the school year at Communication & Media Arts HS. The student again applied for acceptance at Cass Tech HS during the 2023-24 school year and was accepted in July 2023. She has started the 2023-24 school year at Cass Tech HS. The school and district requested immediate subvarsity eligibility in volleyball and softball at Cass Tech HS given the unique circumstances around her acceptance to Cass Tech HS.

The Executive Committee approved the request for waiver.

Farmington High School (Regulation I, Section 9) – A request to waive the transfer regulation was made on behalf of an incoming 11th-grade student who is transferring to Farmington High School after attending two years at Canton High School where he competed in tennis, swim & dive, and track & field. The student attended Canton HS because his mother was an employee in that district. The student can now drive and wished to attend his school of residence, Farmington HS. The request was for immediate eligibility in all three sports at Farmington HS.

The Executive Committee did not approve the request for waiver.

Flint-Carman-Ainsworth High School (Regulation I, Section 9) – A request to waive the transfer regulation was made for an 11th-grade student who transferred to Carman-Ainsworth High School from Gaylord High School to start the 2023-24 school year. The student is living with his paternal aunt in the Carmen-Ainsworth attendance area after his father's death. After his father died, the student and younger siblings moved in with their grandmother but later left to live with his aunt in the Flint area. The student participated in wrestling last school year at Gaylord HS. Carmen-Ainsworth HS offers the student a chance to get back on track academically while living in a supportive home environment. Supporting information includes documentation of the aunt's guardianship and grade transcripts. The school requested immediate eligibility in wrestling at Carmen-Ainsworth HS.

The Executive Committee approved the request for waiver.

Fruitport High School (Regulation I, Section 9) – A request to waive the transfer regulation was made on behalf of a 10th-grade student transferring to Fruitport High School after two years at Spring Lake High School, where he competed in football and wrestling. The student's younger siblings also attended Spring Lake but made moves to Fruitport for various academic, social, and emotional issues. The family determined that having all three siblings in the same district would be beneficial, and the move for the high school student would have benefits academically and socially. The request was for subvarsity eligibility in football and full eligibility in wrestling.

The Executive Committee did not approve the request for waiver.

Galesburg-Augusta High School (Regulation I, Section 9) – A request to waive the transfer regulation, specifically Interpretation 62 (public school of residence), was made on behalf of an incoming 11th-grade student who recently moved between parents who were never married to live with his mother. The student attended Portage Central High School, where he lived with his father as a 10th grader and competed in football and basketball. The new residence with his mother is in the Climax-Scotts Public School District. Prior to moving to live with dad in Portage, the student lived with mom and attended Galesburg-Augusta High School as a 9th grader. The new school requested immediate eligibility in all sports at Galesburg-Augusta HS pending an otherwise completed and approved Educational Transfer Form.

The Executive Committee approved the request for waiver with an otherwise completed and approved Educational Transfer Form.

Grand Blanc High School (Regulation I, Section 9) – A request to waive the transfer regulation was made for an 11th-grade student who transferred to Grand Blanc High School from Saginaw Heritage High School to start the 2023-24 school year. The student and her family moved into an apartment in Grand Blanc but have not made a full and complete residential move, as their home in the Saginaw area is still being used by the family on the weekends. The student went through some challenges related to the Heritage HS girls basketball program including interactions with her former coach. The student participated in 10 basketball games at Heritage HS before being injured. Supporting information included letters from the student's parents. The school request was for eligibility after 10 games of basketball at Grand Blanc HS.

The Executive Committee did not approve the request for waiver.

Grand Rapids-Forest Hills Central High School (Regulation I, Section 9) – A request to waive the transfer regulation was made on behalf of a 12th-grade student who has transferred to Forest Hills Central High School to start the 2023-24 school year after attending NorthPointe Christian High School. The student participated in volleyball, bowling, and track & field while at NorthPointe Christian HS during the 2022-23 school year. The student experienced issues that impacted her safety and required therapy and hospitalization for the student-athlete. After these incidents, her desire to start afresh led her to Forest Hills Central HS. Documentation from the former school, the hospital, and counselors was included. The school requested immediate eligibility in all sports for the 2023-24 school year.

The Executive Committee approved the request for waiver.

Grand Rapids-Ottawa Hills High School (Regulation I, Section 9) – A request to waive the transfer regulation is made for an incoming 11th-grade student who has transferred from Grandville High School to Grand Rapids-University Preparatory Academy, a theme-based high school within Grand Rapids Public Schools. The student's parents are employed by the Salvation Army, which requires them to move into different communities to serve churches and social service centers. The student and family have lived in several other communities during his life, and the latest brought them to Grand Rapids, where his parents serve as corps officers and senior pastors. The family is in the process of purchasing a new home in the Ottawa Hills attendance area but the purchase still needs to be completed. Given the unique transfer circumstance, the school requested immediate eligibility in soccer, which the student participated in at Grandville HS.

The Executive Committee did not approve the request for waiver.

Grand Rapids-South Christian High School (Regulation I, Section 9) – A request to waive the transfer regulation was made on behalf of a 10th-grade student who competed in 9th-grade basketball for ten games at Thornapple Kellogg High School in 2023 before injuring his knee. The student transferred from Thornapple Kellogg HS at the start of the 2023-34 school year to get a new start after two debilitating knee injuries that required him to miss much of his 8th and 9th-grade participation in basketball. The student desired to attend South Christian HS, where his younger siblings will attend. Documentation in the form of letters of support from the student, former school, and doctors was also included. The request was for eligibility in subvarsity basketball at South Christian HS after ten games.

The Executive Committee did not approve the request for waiver.

Midland-Bullock Creek High School (Regulation I, Section 9) – A request to waive the transfer regulation, specifically Interpretation 62 (public school of residence), was made on behalf of a 10th-grade student who recently moved between parents to live with his father. The student attended Lincoln High School in Arkansas, where he lived with his mother and competed in basketball. The new residence with his father is in the Sanford-Meridian Public School District. The student's father has lived in Sanford for years and has recently battled health issues. The family also has several cousins that attend Bullock Creek HS. The new school requested immediate eligibility in all sports at Bullock Creek HS pending an otherwise completed and approved Educational Transfer Form.

The Executive Committee approved the request for waiver with an otherwise completed and approved Educational Transfer Form.

Midland-Calvary Baptist Academy (Regulation I, Section 9) – A request to waive the transfer regulation was made for an incoming 11th-grade student who transferred to Calvary Baptist Academy from Midland-H.H. Dow High School after attending Dow for her 9th and 10th-grade years. While at Dow HS, the student struggled. The student desired an environment that would support her faith. The student competed in 9th and JV basketball at Dow HS, and the request was for immediate eligibility in basketball at Calvary Baptist Academy.

The Executive Committee did not approve the request for waiver.

Monroe High School (Regulation I, Section 9) – A request to waive the transfer regulation was made on behalf of an 11th-grade student who transferred to Monroe High School from Toledo-Start High School to start the 2023-24 school year. The student is classified as homeless by Monroe Public Schools under the McKinney-Vento Act. The student is living with family friends in Monroe after the incarceration of his father and his mother experiencing a stroke. The student participated in football and baseball last school year at Start HS. Monroe HS offers the student a chance to graduate, and the student is enrolled in the school's Career Tech program. Supporting information included documentation of the student's homeless status. The school request was for immediate eligibility in football and baseball at Monroe HS.

The Executive Committee approved the request for waiver.

Monroe High School (Regulation I, Section 9) – A request to waive the transfer regulation is made for an incoming 10th-grade student who attended Monroe-St. Mary Catholic Central High School in the 2023-24 school year and competed in wrestling and track. The student transferred to Monroe HS to start the 2023-24 school year after experiencing racial issues and being ostracized while at SMCC HS. The former school has confirmed the incident and supports the change of school for the student, indicating that they do not believe it to be athletically motivated but a chance for a fresh start in a school where the student will feel supported and comfortable. The request was for immediate eligibility in wrestling and track at Monroe HS.

The Executive Committee approved the request for waiver.

Rockford High School (Regulation I, Section 9) – A request to waive the transfer regulation was made on behalf of an 11th-grade student who transferred to Rockford High School from Cedar Springs High School for the start of the 2023-24 school year. The student was involved in issues at Cedar Springs HS that forced him to transfer to a new school based upon a facilitated agreement. The student transferred to Rockford, the closest public school to his residence besides Cedar Springs. The student played football at Cedar Springs and desired to do the same at Rockford this fall in the remaining games. Documentation of the matter was provided.

The Executive Committee did not approve the request for waiver.

Sparta High School (Regulation I, Section 9) – A request to waive the transfer regulation, specifically Interpretation 62 (public school of residence), was made on behalf of an incoming 10th-grade student who recently moved between parents to live with her father. The student attended Lakeview High School, where she lived with her mother and competed in softball and basketball. The move was necessitated by a tragic accident involving the student's mother that resulted in one fatality and significant legal issues. The new residence with her father is in the Kent City Public School District. The student's father is remarried and the student's stepsiblings all attend Kent City Public Schools. The new school requested immediate eligibility in all sports at Sparta HS pending an otherwise completed and approved Educational Transfer Form.

The Executive Committee approved the request for waiver with an otherwise completed and approved Educational Transfer Form.

Union City High School (Regulation I, Section 9) – A request to waive the transfer regulation was made for an 12th-grade student who transferred to Union City High School from Battle Creek-Harper Creek High School to start the 2023-24 school year. The student underwent harassment and targeted bullying at Harper Creek related to her father's position at Harper Creek. This was coupled with issues related to the student being questioned and accusations that she did something wrong related to a school investigation. This resulted in physical confrontations and harassment at Harper Creek. Ultimately, the family removed the student from Harper Creek in the second semester before the transfer to Union City to start the school year. The student participated in competitive cheer and track & field while at Harper Creek HS. Supporting information included letters from the student's parents and the former school. The school requested immediate eligibility at Union City HS.

The Executive Committee approved the request for waiver.

Wyoming-Tri-Unity Christian High School (Regulation I, Section 9) – A request to waive the transfer regulation was made on behalf of an 11th-grade student who played four games of basketball while a student at Hudsonville-Unity Christian High School as a 10th-grade student. The transfer to Tri-Unity Christian for the start of the 2023-24 school year is being made for academic reasons related to harassment and needing a new school start. The number of games played was supported by a letter from the former school. The request was for immediate eligibility after sitting out four games of basketball at Tri-Unity Christian HS.

The Executive Committee approved the request for waiver after four basketball games.

Lake Leelanau-St Mary and Leland Middle Schools (Regulation III, Section 1[D]) – The Executive Committee approved a cooperative program in baseball and softball (6th, 7th and 8th grades combined) between these schools. St Mary will be the primary school.

Lawrence and Paw Paw-Trinity Lutheran Middle Schools (Regulation III, Section 1[D]) – The Executive Committee approved a cooperative program in baseball (6th, 7th and 8th grades combined), boys and girls basketball (7th and 8th grades), competitive cheer (6th, 7th and 8th grades combined), softball (6th, 7th and 8th grades combined), boys and girls track & field (6th, 7th and 8th grades combined) and wrestling (6th, 7th and 8th grades combined) between these schools. Lawrence will be the primary school.

Flint-Southwestern Classical Academy – A request was made to allow Flint Southwestern Classical Academy to add their Accelerated Learning Academy program to their enrollment declaration for the 2023-24 school year. The ALA students were counted in the overall enrollment of 858 eligible students, but the ALA program was left off as one of their alternative programs for Flint-Southwestern Classical Academy. The ALA program has been included as an alternative program for Flint-Southwestern Classical Academy in past enrollment declarations, and the omission was made in error. The ALA program has 163 students in the program. The school asked that their ALA students be allowed to compete; they will count these students in future enrollment declarations. The potential change will impact no sports classifications or divisions for Flint-Southwestern Classical Academy.

The Executive Committee approved the request for waiver.

New Member Schools – Pursuant to the MHSAA Constitution adopted by member schools and according to procedures for MHSAA membership adopted by the Representative Council on March 27, 1997, the Executive Committee approved membership for the following school:

Plymouth-Ivywood Classical Academy is a public charter school. It operates within its own building that houses grades K-9. Ivywood Classical opened its doors in 2019. The school focuses on providing students Classical education fashioned after the Hillsdale College educational model. Hillsdale College is also the sponsor of the Charter. The enrollment is approximately 660 students in grades K-9, with about 45 in the 9th grade level. The school currently fields soccer, volleyball and cross country teams and competes in the Michigan Independent Athletic Conference. MHSAA staff conducted an on-site visit on September 29, 2023. An Athletic Department Code of Conduct and Handbook was submitted. A signed 2023-24 Membership Resolution and Preliminary Classification Form were received on September 18, 2023. The school will be eligible for MHSAA tournaments for the 2024-25 school year.
