The 2025-26 MHSAA Boys Lacrosse Committee met in the John E. "Jack" Roberts MHSAA building to review topics involving boys lacrosse and the tournament series. The week prior to the meeting, the committee received the published minutes of the two previous committee meetings.

The committee also received several reports for their review, including the 2025-26 classification of teams and enrollment breaks set in March 2025, and a list of current cooperative programs. The meeting began with a review of the MHSAA decision-making process and the charge of the Boys Lacosse Committee, including the unique functions related to seeding. # 2025-26 REGIONAL ASSIGNMENTS & TOURNAMENT

One of the unique functions of the committee is its role in preseason seeding and tournament alignments. No changes were made to the seeding criteria for the preseason. The committee ranked the top eight teams 1-8 in each division based on the criteria and placed one seeded team in each region. The regions will be finalized pending MHSAA staff securing host sites. Regions without hosts designated will be posted on MHSAA.com as soon as possible following the October meeting, including any new programs or cooperatives notifications and approvals. On Wednesday, May 2, 2026, the committee will reconvene and place each team on the bracket based on the written criteria and current season competition played on or before Monday, May 4, 2026.

# **2026 TOURNAMENT CALENDAR**

The committee reviewed the 2026 tournament calendar. The MHSAA is exploring options for hosts as well as format for the 2026 Boys Lacrosse Finals.

## POSTSEASON TOURNAMENT FORMAT

The committee once again discussed proposals put forth by MHSAA staff regarding the MHSAA tournament format and seeding. The MHSAA will work with the lacrosse coaches association to develop a proposal to put forth to their membership for consideration in the future.
