- 1. First and 10 for team A from its 20-yard line. A1 takes the snap and throws a backward pass to A2. A2 begins to advance but faces a heavy rush. He is outside the lateral boundary of the free-blocking zone as established at the snap when, at his own 15-yard line, he throws a pass that crosses the sideline at team A's 24-yard line.
 - a. Foul for intentional grounding because A2 did not receive the snap.
 - b. Foul for intentional grounding because there was no eligible receiver in the area of the pass.
