

## 2023-24 Volleyball Officials Exam for Postseason Tournament Consideration & Answers

1. Teams will not switch benches unless:
  - a. Host management determines that one side of the court has a disadvantage.
  - b. R1 determines that one side of the court has a disadvantage.

2. Which of the following is true about the MHSAA Official's uniform?
  - a. All officials must dress alike.
  - b. Shirts must be white (or bright blue, if both R1 and R2 agree) with horizontal MHSAA logo on the left chest.
  - c. Shoes, socks, and slacks must be black.
  - d. All of the above.
3. For teams with fewer than six players, each time a vacant position rotates to serve in the right back position, the next server by rotation shall assume the serve.

4. Prior to the deciding set, the captain from which team calls the toss?

5. A spectator becomes unruly and disruptive to the orderly progress of the set. The individual responsible for resolving the situation is:

6. Which of the following is incorrect concerning the first referee? The first referee must have:

9. During warmups prior to the match, the referees notice a player on Team A wearing plastic beads at the end of long braids. The braids are free-flowing, allowing the braids to sway back and forth as the player moves.
  - a. All beads are legal and the player can participate in the match with those adornments.
  - b. Beads are only legal if securely fastened to the head and do not present a risk of injury to the player, teammates or opponents. The referees should notify the coach of Team A that the player must legally secure the beads before being allowed to participate.
  - c. Beads are illegal and the referees should notify the Team A coach that the player must remove the beads from the hair to participate.
  
10. During warmups prior to the match, the referees notice some Team A players wearing spandex with multiple logos on the waistband, in addition to the 2¼ square inch logo found on the bottom of the leg of the spandex.
  - a. There are no restrictions to the number or the size of logos on the waistband of uniform bottoms, and the spandex is deemed legal.
  - b. Logos on the waistband of uniform bottoms are limited to one and must meet the same size restrictions as the logos on the legs of the spandex. The referees shall notify Team A's coach that the players will need to change their uniform bottoms or be penalized by awarding a loss of rally/point to Team B to start the match.
  - c. Logos on the waistband of uniform bottoms are limited to one and must meet the same size restrictions as the logos on the legs of the spandex. The referees shall notify the head coach of team A that the uniform bottoms are out of compliance and notify the state association for further penalty, however there is no penalty assessed to start the match.
  
11. The following are true regarding the serve, except:
