- Host:** Grand Rapids Forest Hills Northern Eastern and Milford High School Ski Teams
- Lift Tickets:** **RACE DAY:** \$15 for each team member racing in the meet on race day and will be given (2) complimentary coach lift tickets. Each additional team member not racing in the finals will be charged \$27 for lift tickets. All other tickets are sold at regular rates. Pre-purchase tickets by calling (231) 533-8621, ext. 3379 by 2pm the SUNDAY PRIOR TO RACE DAY (tickets will be available for pickup at Ivan's on Monday morning). Tickets will also be available to be purchased at Ivan's until 9am on race day. Team members who are racing in the MHSAA Finals competition may purchase \$35 full day tickets on Saturday and Sunday prior to the State meet. These tickets must be purchased each day by the coach of each team as a group and the coach must provide a list of who the tickets are for. - Team Areas:** Tents may be set up toward the bottom of the blue lift near Ivan's Cafe. The area will be marked. Team food can be brought into Ivan's, all teams will have assigned tables. Individuals will have tables as well. Outside food is allowed, however due to electrical limitations, **NO CROCKPOTS** are allowed in Ivan's. Crock Pots are allowed in the day lodge near the yellow lift, with limited space.
- Waxing:** First come, first served. **SUMMIT VILLAGE:** Sunday 4–8p Parlor D | **CEDAR RIVER VILLAGE:** Sunday 8a-4p Office D, 4-8p The Boardman
- Bibs:** Racers must wear the bib issued to them by the host team and must be visible during racing AND inspection. Failure to wear the bib issued shall result in disqualification. If a bib is damaged during the event, a replacement bib may be obtained by the team member's coach. Replacement bibs will be issued by the Electronic Timekeeper (via the Starter). AFTER the meet, the individual must return the bib to the person collecting bibs at the bottom of the race hill or the meet manager (if one did not turn in after run). School is responsible for any bib not returned to the host. Schools will be charged \$50 (payable to MHSAA) for any missing bibs.

I, _____, Individually (or as Parent or Guardian of _____, a minor, if applicable), hereby state that I am aware that all winter activities, including but not limited to racing, skiing, snow boarding, tubing, fat tire biking, snow shoeing, hiking and other snow sports and special events (collectively "Snow Sports") are action events and involve many RISKS, DANGERS and HAZARDS from, including, but not limited to: falls, riding and disembarking ski lifts; changing weather conditions; exposed rock, earth, ice and other natural objects including but not limited to trees, tree stumps, and forest dead fall; the condition of snow or ice on or beneath the skiing, snowboarding, tubing, fat tire biking, snow shoeing or hiking surface; changes or variations in the terrain which may create blind spots or areas of reduced visibility; changes or variations in the snow surface or subsurface, including changes due to man-made or artificial snow, variable and difficult snow conditions; streams, creeks and exposed holes in the snow pack above streams or creeks; snowcat roads, road-banks or cut-banks; impact or collision with lift towers, fences, marked and unmarked snow making equipment, snow grooming equipment, snowmobiles or other vehicles, equipment or structures; impact or collision with other skiers, snow boarders, tubers, fat tire bikers, snow shoers, and hikers; the failure to ski, snow board, tube, bike, snow shoe, or hike safely or within one's own ability or within designated areas; equipment failure or malfunction; negligence of other skiers, snowboarders, tubers, fat tire bikers, snow shoers and hikers, and; negligence on the part of Shanty Creek Resorts, its employees, volunteers, owners, officers, representatives, directors, shareholders, agents, affiliates and vendors. I am also aware that the RISKS, DANGERS and HAZARDS referred to above exist throughout the Shanty Creek Resort area and that many are unmarked. I agree to accept any and all risks involved with skiing, snowboarding, and any snow sports activities.
