### **INTRODUCTION & PURPOSE**

The committee was provided the "Ten Basic Beliefs for Interscholastic Athletics in Michigan." The following items were discussed and debated during the meeting.

### **DISCUSSION ITEMS**

The group discussed the recent approval from the Representative Council in regard to allowing additional seeds at the state finals at #1 Singles, as well as the newly implemented "Ball Fee" which is applied at the Regional and Finals.

The MHSTeCA "Claims Committee" continues to be recognized and thanked for its usefulness as an advisory group both prior to an issue as well as after an issue has been reported.

The group discussed the importance of sportsmanship and steps that could and would be taken to promote appropriate sportsmanship as it pertains to all present at MHSAA tennis event.

TennisReporting.com was again discussed, with the committee in full support of its continued use.

Concussion information was provided regarding the 2021-2022 tennis season and compared with data from previous seasons.

There are currently no known changes for 2023-2024 regarding USTA Rules.

### 2023-24 FINALS TOURNAMENT SITES (TENTATIVE)

The MHSTeCA, as well as the Tennis Committee, both support the current system of rotating Final sites for Divisions 1, 2, 3, and 4. Sites would tentatively be the same for both boys and girls of the same Division. Tentative assignments for the 2023-2024 school year are as follows:
